That, subject to payment aforesaid, we remise, release and forever discharge and hold harmless The St. Lawrence Seaway Management Corporation, Her Majesty the Queen In Right of Canada, their representatives, employees, agents, successors and assigns thereof from any and all actions, causes of action, claims and demands whether now in being or in future arising in respect of the said contract and of the performance of all works in conjunction therewith.

**A false or fraudulent declaration is a contravention under the Criminal Code, and carry penalties including fines or imprisonment.**

**NOTE 1.** Where Contractor is a corporation or a partnership, declarer's position in the corporation or partnership and the corporation or partnership name should be clearly shown in No. 1. Where Contractor is the person who makes the declaration, strike out "of" in the first line of No. 1.

**NOTE 2.** Where the Contractor is an individual he must make the declaration himself. Where the Contractor is a partnership the declaration must be made by one of the partners. Where the Contractor is an incorporated company the declaration must be made by the President, Vice-President, Secretary, Treasurer or a Director. If any other person makes this declaration, two copies of the by-law issued under the Corporation Seal authorising the individual to execute documents must be submitted with the first declaration on each contract.
